## Village hall car park charging

As from 1 April 2018, the village hall committee will be applying a new regime to parking at the village hall car park. For those people using the facilities at the hall, school, shop, toilet, bowling club, football club or play area, parking will be free whilst the vehicle's owner is on site. For all other users, the basic fee for parking is £1 for 24 hours. Tickets are available to purchase from the community shop. If the shop is closed when you need to purchase a ticket, please text Bob Egerton on 07785 748844 with your name and registration number and we will make arrangements to sell you a ticket at a mutually convenient time. If you are likely to be a regular user of the car park, we advise you to consider buying an annual permit or a book of pre-paid tickets.

#### Terms and conditions of use of car parking permits or tickets

- 1. An annual permit or car parking tickets entitles the owner of the vehicle to park in the car park whilst not using the facilities on the site.
- 2. The permit or ticket does not guarantee that a space will always be available
- 3. Permit and ticket holders must park their vehicles as considerately as possible for others users of the car park. Please park within the designated spaces. Do not park in the bays marked for disabled users. Please try to avoid parking in the spaces closest to the shop if at all possible.
- 4. Permit and ticket holders should be prepared to move their vehicles to another position in the car park if reasonably requested to do so by a member of the village hall committee or by the manager or volunteer at the shop.
- 5. Permit and ticket holders will not be able to park in the car park on any of the following days: On local produce market days, i.e. last Saturday of each month, from 9 a.m. until 2 p.m. On antiques market days, i.e. third Sunday of each month, from 8 a.m. until 5 p.m. On Carnival day, i.e. first Saturday of September, from 5 p.m. on the Friday evening until 10 p.m. on Carnival day
  On any other day specified by the village hall committee who will give at least 3 days' notice of such days.
- 6. For residents with more than one vehicle in the household, the permit can be used for either vehicle but for only one vehicle at any one time.
- 7. The pre-paid tickets can be used on any car owned by the resident or can be used by visitors.
- 8. Any vehicle parked in the car park without a valid permit or ticket will receive a warning letter advising them to purchase an appropriate ticket or permit. Persistent offenders may be banned from using the car park completely.
- 9. Any vehicle breaching the no-parking days will similarly receive a warning letter and persistent offenders may be banned from using the car park completely
